#### EVENT TERMS

PLEASE READ THIS EVENT TERMS CAREFULLY. BY REGISTERING FOR OR PARTICIPATING IN THE EVENT, YOU AGREE TO BE BOUND BY ALL TERMS DESCRIBED HEREIN AND ALL TERMS INCORPORATED BY REFERENCE. THIS AGREEMENT CONTAINS, AMONG OTHER THINGS, A LIABILITY RELEASE AND WAIVER.

Schedule of the Event is subject to change without notice.

Any individual without prior registration and a pass (and parental or guardian authorization, if applicable) will be denied entry into the venue.

## 2. Participant Entry and Eligibility.

The Event is open to Spectators on January 18 and January 19, 2025. To register to attend the Event as a Spectator, you must be above the age of 13 years old at the time of registration, OR, if you are minor below the age of 13 at the time of registration, you must be able to submit the duly completed authorization form available here, signed by your parent or your legal guardian. You must also complete the form and register as a Spectator on Eventbrite and agree to this Agreement. Spectator passes are free. Passes cannot be sold or transferred. Spectators must show a valid, government issued form of photo before participation. Spectators without an acceptable photo ID or a Spectator pass will be denied entry into the venue.

#### 3. Prizes and Gifts.

Spectators who register with a Limited Ticket, will receive a goody bag at the venue.
